
Methodology

- **Population** The province of Alberta has a total population of 3,720,946 residents (July 1, 2010) approximately 77% of which are 18 years of age or older for an adult population of approximately 2,856,000.
- Sample Data were collected by Lethbridge College and Athabasca University students enrolled in STS270 Social Science Research Methods and PSC150 Local Government in the fall of 2010. Students interviewed 1,067 adult Alberta residents by telephone from October 2nd to 3rd 2010 under the supervision of Canadian Studies faculty members Faron Ellis PhD and Marda Schindeler MA. Telephone numbers were selected from a sample drawn from InfoCanada directories. We sincerely thank all participants who took time out of their day to respond to our inquiries. - Representativeness Analysis of the demographic data indicates that, within acceptable limits, the sample accurately represents the demographic distribution of the adult population within the province of Alberta. The sample has been statistically weighted where necessary to even better reflect the demographic distribution of the population (gender and age).
- Confidence The weighted sample yields a margin of error of + 3.0 percentage points, 19 times out of 20. The margin of error increases when analyzing sub-samples of the data (Calgary + 5.1 percentage points, Edmonton and immediate area + 5.3 percentage points, North + 7.2 percentage points, South + 7.6 percentage points, 19 times out of 20).

Albertans' opinions on oil and gas resource royalty rates

- Clearly, Albertans are divided over royalty rates. Furthermore, almost one in five (18.5%) Albertans do not know how to judge the current royalty regime. This isn't unexpected given the multiple changes to the royalty regime over the last three years.
- Of the Albertans who stated an opinion, nearly two in five (38.2%) think royalty rates are at about the right levels, while over one-third (34.9%) think they are too low. Slightly over one-quarter (26.8%) think royalty rates are too high.
- Extreme opinions are not the norm. For example, three times as many Albertans think that royalty rates are only somewhat too high (16.8%) as opposed to far too high (5.1%). Similarly twice as many think that royalty rates are somewhat too low (18.1%) compared to the 10.2% who think they're far too low. (See Appendix)
- On a regional basis, Edmonton stands out from the rest of the province in that it is the only region where a majority (55.9%) of residents believe royalty rates are too low. Compared to Calgary (4.1%), Edmonton (20.8%) has five times as many residents who think royalty rates are far too low. In all other regions of the province, opinion is much more divided. Southern Albertans lean slightly towards the too low position (33.3% vs. the 26.8% who think they're too high). More Calgarians (32.2%) and Northern Albertans (34.8%) believe royalty rates are too high than those in each region who believe rates are too low (21.4% and 25.5% respectively).

Albertans' Opinions on Royalty Rates by Demographic Characteristics (%)

Some interesting differences of opinion are measured between various demographic groups. For example, although women (25.9%) are much more undecided than are men (11.2%), of those who expressed an opinion, men are significantly more likely to think rates are too low than are women (27.9%). Men (40.5%) are twice as likely to think rates are too low than think they are too high (18.8%). Women are much more evenly split, with only one-quarter (27.9%) thinking they are too low compared to those who think they are too high (36.8%).

Interestingly, income level does not impact opinion in any significant manner.

- Education significantly impacts opinion with university grads distinguishing themselves from other education groups by being most likely to think rates are too low. In fact, twice as many university grads believe royalty rates are too low than those who believe they are too high. All other education groups are much more evenly divided.
- Age has a significant impact on opinion with younger Albertans more likely to think royalty rates are too high (30.1%) compared to only 17.8% of seniors who think similarly.
- Albertans' perspectives about their future economic prospects has a significant impact on opinion. Those who believe their personal economic situation will improve over the next year are more likely to believe rates are too high (31.8%) and less likely to believe they are too low (30.7%) than those who think their economic situation will stay the same or worsen.

Clear partisan differences in opinion on royalty rates exist with Progressive Conservative and Wildrose Alliance supporters more evenly divided on the issue than are Liberal (47.9%) and NDP (56.3%) supporters who are much more likely to think rates are too low.
