Methodology

- Population The city of Lethbridge has a total population of 86,659 residents (2010 municipal census) approximately 80% of which are 18 years of age or older (69,327). A total of 42,373 Lethbridge residents are male (48.9%) while 44,286 are female (51.1%). South Lethbridge is home to 30,144 residents (34.8%) while the rapidly expanding west side is now home to 31,399 residents (36.2%). There are 25,116 north Lethbridge residents (29.0%). Coaldale has a total population of 6,943 residents (2009 Census).
- Sample Data were collected by Lethbridge College and Athabasca University students enrolled in STS270 Social Science Research Methods in the winter of 2011. Students interviewed 771 randomly selected, adult Lethbridge and Coaldale residents by telephone on February 12–13, 2011 under the supervision of School of Liberal Arts faculty members Faron Ellis, PhD and Marda Schindeler, MA. Telephone numbers were selected from a sample drawn from InfoCanada directories. We sincerely appreciate and thank all those who took time to respond to our survey. - Representativeness Analysis of the demographic data indicates that, within acceptable limits, the sample accurately represents the demographic distribution of the adult population within the city of Lethbridge. The sample has been statistically weighted to even better reflect the population (gender, age and area of the city).
- Confidence The weighted sample yields a margin of error of ± 3.51 percentage points, 19 times out of 20. The margin of error increases when analyzing sub-samples of the data. For example, the Lethbridge subsample margin of error is ± 3.77 percentage points, 19 times out of 20, and ± 9.52 percentage points for the Coaldale subsample.


Alderman vs. Councilor Title for Those Elected to Lethbridge City Council

When asked their preferences concerning what title those elected to the Lethbridge City Council should hold, more Lethbridge residents (44.6%) stated that they preferred to keep the title of alderman than change to councilor (29.8%). Fully one-quarter of all decided respondents (25.6%) insisted that they did not care what the title was.

It is important to note that respondents were not prompted with the Don't Care response. Rather, each of those who provided that response did so voluntarily and continued to tell us to record that response even after being

probed to select one or the other of the prompted responses.

- Interestingly, no significant gender differences were measured with men (46.1%) only slightly more likely than women (43.5%) to prefer continuing with the title alderman.
- No significant differences are measured between areas of the city, income levels or religious participation.
- Age has a significant if somewhat counterintuitive impact on opinion. The youth (57.6%) are most supportive of continuing with alderman while seniors (37.6%) are the only age group to have slightly more support for changing to councilor than maintaining the status quo. Seniors are also most likely to state that they don't care (29.8%).
- Clearly, this is not a pressing issue for most Lethbridge voters.

Alderman vs. Councilor Title for Those Elected to Lethbridge City Council (%)

- When analyzing opinion among different age and education groups while controlling for sex, we discover that age does have more significant impact on male opinion than on female opinion. Young men are the most supportive of maintaining the title of Alderman (65.4%) while a majority of gen-x women are also supportive of maintaining that title (52.9%). More women in all groups except seniors would prefer to keep the title of Alderman.
- Education has no significant impact on either male or female opinion on this issue.
