## Methodology

Population The city of Lethbridge has a total population of 98,198 residents ( 2017 census) approximately $80 \%$ of which are 18 years of age or older ( 78,500 ). A total of 48,173 Lethbridge residents are male (49.1\%) while 50,002 are female ( $50.9 \%$ ). South Lethbridge is home to 31,660 residents ( $32.2 \%$ ) while the rapidly expanding west side is now home to 39,085 residents (39.8\%). There are 27,453 north Lethbridge residents (28.0\%).

Sample Data Collected by Lethbridge College students enrolled in 9 sections of 6 courses in a variety of Lethbridge College programs in the winter of 2018. Students interviewed 1,288 randomly selected adult Lethbridge residents by telephone from February 10-15, 2018 under the supervision of CSRL Research Chair, Dr. Faron Ellis. We sincerely appreciate and thank all those who took time to respond to our survey. Representativeness Analysis of the demographic data indicates that, within acceptable limits, the sample accurately represents the demographic distribution of the adult population within the city of Lethbridge. The sample has been statistically weighted to even better reflect that of the population (sex, age, and area of the city of Lethbridge).

Confidence The sample yields a margin of error of $\pm 2.7$ percentage points, 19 times out of 20 . The margin of error increases when analyzing sub-samples of the data.

IB Commons Call Centre The CSRL operates as a division of the Centre for Applied Arts and Sciences. Students conducted interviews using the facilities of the Lethbridge College IB Commons Call Centre with support from the Lethbridge College Facility Management, Instructional Technology, and Audio Visual teams.

Sponsorship These data are part of a larger study of the opinions and attitudes of Lethbridge residents conducted by the Citizen Society Research Lab at Lethbridge College. This particular set of questions was derived from student, faculty and community interest in the topic.

## Policy Issues - Summary

## Same-sex Marriage

A clear majority of Lethbridge residents (77.3\%) support same-sex marriages having equal legal status with traditional marriages. Support for same-sex marriage has increased significantly from only $33.5 \%$ in 2002 when we first asked Lethbridge residents about this issue. Women (81.8\%), the non-religious (88.0\%), upper income residents (84.1\%), middle-aged residents, provincial NDP (88.9\%) and Liberal ( $84.1 \%$ ) voters are most supportive. Highly religious residents ( $56.6 \%$ ), seniors ( $69.1 \%$ ), and provincial UCP voters ( $68.2 \%$ ) voters are less supportive, although majorities of each of those groups is supportive.

## Abortion Choice

A clear majority of Lethbridge residents (81.7\%) support a woman's right to choose to have an abortion. Men (81.2\%) are just as supportive as are women (82.4\%). Furthermore, substantial majorities in most demographic categories demonstrate strong support. Middle-aged Lethbridge residents ( $85.1 \%$ ) are more supportive than are seniors ( $81.9 \%$ ), those 30 to 44 years of age ( $80.7 \%$ ), and the youth ( $80.0 \%$ ). Religion, however, is the most important determent of opinion. But even here, a clear majority of the very religious ( $61.1 \%$ ) are supportive of a woman's right to choose. Support climbs to $86.4 \%$ among the somewhat religious, peaking at $93.4 \%$ among the non-religious. Some partisan differences are measured with provincial UCP voters (74.4\%) somewhat less supportive than are NDP (92.1\%) and Liberal (89.2\%) voters, but strong majorities of all provincial partisans are supportive.

## Capital Punishment

A majority of Lethbridge residents ( $64.0 \%$ ) support Canada reintroducing capital punishment for people convicted of first-degree murder. Religiosity, education, and provincial partisanship are the most important determinants of opinion on this issue. For example, the most religious Lethbridge residents are least supportive of reinstating capital punishment ( $59.5 \%$ ), although a majority are still in favor. Majorities of university graduates (51.9\%) and provincial NDP voters ( $60.8 \%$ ) are opposed, while substantial majorities of all other education groups, and provincial UCP supporters (73.3\%) are more supportive.

## Legal Medical Marijuana

A substantial majority of Lethbridge residents (89.5\%) support marijuana remaining legal for medical purposes. Strong majorities in all demographic categories are supportive.

## Legal Recreational Marijuana

Lethbridge residents are evenly split in their support for ( $50.0 \%$ ) and opposition to ( $50.0 \%$ ) legal recreational marijuana. Support has fluctuated over past two years after steadily increasing from only $31.5 \%$ in 2005 . Support is strongest among men ( $56.4 \%$ ), the nonreligious (61.3\%), the youth (68.2\%), and provincial NDP partisans (69.0\%). Opposition is strongest among seniors (69.8\%), provincial UCP supporters (61.6\%) and the very religious (66.3\%).

## Legalize Doctor-Assisted Suicide

A substantial majority of Lethbridge residents support legal doctor-assisted suicide (79.5\%). Religion is the most important predictor of opinion. A slim majority of the very religious are supportive ( $51.8 \%$ ). Support climbs to $93.5 \%$ among the non-religious. Substantial majorities of all other demographic groups are supportive, including all groups of provincial party partisans.

## Policy Issues Index (means)

An index of opinion structure was created by summing the responses to the six questions thereby allowing for easier regional and demographic comparisons. The index scores range from a possible " 0.0 " for the most traditional respondents, to " 6.0 " for the most progressive. A score of 3.0 represented the midpoint of the range. The graph is organized with Alberta-wide data featured above the bar and Lethbridge data below the bar.

As the data demonstrate, over time, Lethbridge public opinion is becoming more progressive on this basket of issues, as is public opinion in the province as a whole. Over the course of a decade, Lethbridge public opinion has moved considerably towards the progressive end of the spectrum ( 3.2 in 2004, to 3.4 in 2009, to 4.0 in 2018).
