1.0 Call to Order

He acknowledged the passing of Lethbridge College grandparent Louise Saloff. Michael and Paula both spoke about the impact on the college community.

Paula spoke about the changes to the Reform of Agencies, Boards and Commissions Compensation Act that affects the Dean and Director level of position, sharing that the Council of Post-secondary Presidents of Alberta (COPPOA) is assessing the impacts on the post-secondary system.

7.0 Board Chair Report

Michael spoke about the board chair and Presidents meeting with the Minister of Advanced Education to discuss the strategy launch for Alberta 2030: Building Skills for Jobs. Michael shared that he was pleased to see that the government will be expanding the focus on indigenous learners within the goals and priorities.

Michael spoke about his experience at the College and Institutes Canada's (CICan) annual conference, Changing Narratives, and shared the highlight for him was the keynote speakers.

8.1 Academic Council

8.1.1 Health Care Aide Certificate Termination
