Michael thanked the associations for their reports.

Michael asked if there were any questions or comments. Perry asked if there will be a response to the AUPE questions that were in the report. Coreen brought up that there have been conversations between the appropriate people in regard to Jill Siewert-Lemieux's report.

It was also asked if we have a plan for better snow removal this year in response to AUPE identified concern. Tracy responded that Wim Chalmet does have a clearer plan for this year and that it has been communicated to appropriate parties. There are priority levels for snow removal around Lethbridge College.

#### 6.0 Executive Leadership Team

6.1 President and CEO Report – Dr. Brad Donaldson



Lethbridge College had more international students than expected, this created a surplus. Tracy and the finance team are looking at a strategy for some of the surplus. There have been 2 approved uses for a portion of the surplus. One being, gifting approximately \$100K to the LCSA. Tracy met with them and are awaiting some ideas for the use of these funds. The second approved usage is to increase the current bursary that is available for emergency situations.

With the increase in international enrollment, there has been a strain on supports for these students. There has been approval for the hiring of 4 new positions to help support the international students.

Charlie McArthur presented to the Executive Leadership Team in November on the Southwest Alberta Graduate Retention Strategy. Input to be considered in future planning.

Kenny summarized that he has initialized 4 international strategy working groups. These groups will analyze where there needs to be more international student support.

Brad summarized where we are at with the Polytechnic status. Brad has met with the University of Lethbridge President, Digvir Jayas and he has given Lethbridge College their support. There will be a Memorandum of Understanding (MOU) drafted and signed between the 2 institutions. Perry asked, is there a concern of competition on degrees from the University of Lethbridge? Brad assured the board that the MOU will have definitive language that supports both Lethbridge College and the University of Lethbridge.

Brad held 3 Road to Ready town halls at the beginning of November, and they were well attended with over 300 people both online and in person. The feedback on the Mission, Vision, Values was great and there was strong endorsement from the institution.

#### 6.2 Update on implementation of Road to Ready

Brad presented a PowerPoint which spoke to the next steps of Road to Ready known as the Road Ahead. Michael brought up that he appreciates how digestible this presentation was and that there is a clear path to the next steps.

Michael spoke with Minister Sawhney's Chief of Staff, Sarah Amiry at the Government of Alberta, she mentioned that the support for Lethbridge College to go Polytech status is there and that she will be in contact with more information very soon.

Perry summarized what was spoke about at the last Governance and Human Resources Committee meeting on November 14, 2023 and thanked the committee for their hard work on the review of the policies.

It was noted that board evaluations are coming in January and that they would be reviewed at the March 2024 retreat. The March retreat will also be a ¾ day and we are looking at changing the date of it. More information on a new date will come in December.



EL-15 Naming of College Facilities, was not ready for approval at the last meeting and it will be coming back for review at the January 16, 2024 meeting.

Michael brought up that we will need 2 new Board members in June 2024, if anyone knows anyone, please put them forward to him. We will talk more about this at the January 2024 board meeting.

#### 8.4 Finance, Audit and Risk Committee - Janene Moch

The committee met on Nov 7, and they went through the enterprise risk register. It was agreed that we should look at this two times a year.

The surplus of Lethbridge College was also talked about, and Tracy advised that two options have already been approved for some of the surplus. Lethbridge College is increasing the bursary from the current \$40K this year to \$200K. We have also partnered with the Lethbridge College Students Association to donate to their food bank. LCSA will be submitting an RFD for this.

# 9.0 Lethbridge College Annual Report 2022-23

There were some concerns about language and a few statistics that will be looked at before going to print. Brad also explained, that next year there will more graphics and pictures, the board was encouraged to have a look at Lakeland college's annual report.
